Henderson County Emergency Services District No. 8 Minutes for Regular Meeting – July 1, 2024

In compliance with the provisions of Chapter 551, Texas Government Code, notice is hereby given of a regular meeting of the Board of Commissioners of Henderson County Emergency Services District No. 8, to be held at 10:00 am on July 1, 2024, at District 8 Fire Station #1, 9518 FM 773, Murchison, Texas 75778 for the following purposes:

1. Call meeting to order; Meeting was called to order at 10:02 by Phil Elery. In attendance were all commissioners (Howard Calloway by phone), Fire Chief Brandon Irby and Deborah Deas.

PUBLIC COMMENT

2. Public Comment: Members of the public may speak for up to three minutes on any agenda item listed below. Additionally, members of the public may speak on topics not listed on the posted agenda. In accordance with the Texas Open Meetings Act, any response to a public comment that is made on an item that is not on the posted final agenda will be limited to a statement of factual information or a statement of existing policy given in response to the public comment. Any deliberation or decision by the Board regarding public comment on items not on the posted agenda must be limited to a proposal to place the subject on a future agenda.

Debra Deas wanted to share her contact information so someone could let her know why the minutes from April 1st were not approved, why there was no notification of the workshop held prior to the regular scheduled meeting at 10 am, and would like mentioned who is at each meeting. She asked Brandon Irby how the Volunteer Fire Dept. was funded at the informational meeting prior to ESD No. 8 being formed and he stated by payment from the county and donations. She stated she would like to see most or all of the taxpayers money be spent on securing property and for the building of two facilities with contracts being executed for the first one in 2024.

3. Discuss, consider and take action on obtaining a Treasurer's bond; Phil Elery made a recommendation for a postponing until the meeting in September and was second by John Johnson.

- Update from District subcommittee to address obtaining property and building new fire stations in the District; John Johnson had no further information but hoped to have additional information shortly from the appraiser.

 Public Information Act and the Texas Open Meetings Act; Ashley Elder has
 completed all training and provided completion forms.
 - 6. Update on publication of notice of address of administrative office location; John Johnson has paperwork needed and is to present to Phil Elery.

Receive monthly report from District 8 Fire Rescue regarding emergency operations, apparatus, response times, call volume, training, and management activities and take any related action; Fire Chief Brandon Irby stated there were 43 calls for service and the average responders was 4 for the month of June.

- 10. Update on adopting a resolution establishing October 1 September 30 as fiscal year for the District; **No action has been taken**.
- 11. Update on securing contract for Tax Assessment and Collection Services with Henderson County; Phil Elery turned in contract to Peggy Goodall on May 29th.

- 12. Discuss, consider, and take action on possible interim funding options for the District; Ashley Elder had discussions with First State Bank and Phil Elery suggested that Phil and Ashley would set-up a sub committee for discussions for options for funding to report back to the Commisioners.
- 13. Discuss, consider, and take action on establishing District depository bank account(s) and investment account(s); No actions taken
- 14. Update on Resolution Regarding Investment Policy, Strategies, Guidelines and Management Practices for District and Designate Investment Officer; No actions taken
- 15. Discuss and consider adopting the tax and budget planning calendar for 2024 and authorize payment for tax process publications. **No actions taken**
- 16. Discuss and consider status of District website, accessibility, and posting requirements and take any related action. Logo for ESD No. 8 and what will be posted on the website will be discussed with the Carlton firm to make the website user friendly and give the public the information they are needing.

Phil Elery stated the percent of taxes for taxpayers is due by September 1st and he would verify with the county tax office.
